

**PhillipMart Announces Pre-IPO Share Price of  
 Greentown Service Group Co. Ltd. (Stock code: 2869)**

(Hong Kong – 11 Jul 2016 ) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Greentown Service Group Co. Ltd. (“Greentown”; stock code: 2869) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Greentown on PhillipMart were HK\$1.95 and HK\$1.89. The price closed at HK\$1.95 per share, 2.01% lower than its offer price of HK\$1.99. The price opened at HK\$1.89, with the most actively traded price of HK\$1.95 per share, and a turnover of 50,000 股 shares. The total trading volume reached 72,000shares with **total turnover of 139280**. The final price of Greentown, to debut trading tomorrow has been fixed at HK\$1.99 per share.
