## **PhillipMart Announces Pre-IPO Share Price of** AL GROUP LIMITED (Stock code: 8360)

(Hong Kong – 11 Jul 2016) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of AL GROUP LIMITED ("AL GROUP"; stock code: 8360) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for AL GROUP on PhillipMart were HK\$0.83 and HK\$0.68. The price closed at HK\$0.78 per share, 21.88% higher than its offer price of HK\$0.64. The price opened at HK\$0.7, with the most actively traded price of HK\$0.79 per share, and a turnover of 1,600,000 shares. The total trading volume reached 7,188,000 shares with total turnover of 5,509,000. The final price of AL GROUP, to debut trading tomorrow has been fixed at HK\$0.64 per share.
