

**PhillipMart Announces Pre-IPO Share Price of
 Plover Bay Technologies (Stock code: 01523)**

(Hong Kong – 12Jul 2016) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Plover Bay Technologies (“Plover Bay Tech”; stock code: 01523) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Plover Bay Tech on PhillipMart were HK\$0.6 and HK\$0.52. The price closed at HK\$0.54 per share, 8.00% higher than its offer price of HK\$0.5. The price opened at HK\$0.55, with the most actively traded price of HK\$0.53 per share, and a turnover of 2,080,000 shares. The total trading volume reached 6,640,000 shares with **total turnover of 3,709,360**. The final price of Plover Bay Tech, to debut trading tomorrow has been fixed at HK\$0.5 per share.
