PhillipMart Announces Pre-IPO Share Price of Star Properties Group (Cayman Islands) Limited (Stock code: 1560)

(Hong Kong – 12 Jul 2016) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Star Properties Group (Cayman Islands) Limited ("Star Propertie"; stock code: 1560) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Star Propertie on PhillipMart were HK\$2.13 and HK\$1.91. The price closed at HK\$1.97 per share, 9.44% higher than its offer price of HK\$1.8. The price opened at HK\$1.98, with the most actively traded price of HK\$2 per share, and a turnover of 1,668,000 shares. The total trading volume reached 7,852,000 shares with **total turnover of 15,675,620**. The final price of Star Propertie, to debut trading tomorrow has been fixed at HK\$1.8 per share.
