

**PhillipMart Announces Pre-IPO Share Price of
 China Unienergy Goup Limited (Stock code: 01573)**

(Hong Kong – 12 Jul 2016) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of China Unienergy Goup Limited (“China Unienergy Goup Limited”; stock code: 01573) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for China Unienergy Goup Limited on PhillipMart were HK\$2 and HK\$1.8. The price closed at HK\$2 per share, 11.11% higher than its offer price of HK\$1.8. The price opened at HK\$1.8, with the most actively traded price of HK\$2 per share, and a turnover of 274,000shares. The total trading volume reached 764,000shares with **total turnover of HK\$1,465,000.00**. The final price of China Unienergy Goup Limited, to debut trading tomorrow has been fixed at HK\$1.8 per share.
