

PhillipMart Announces Pre-IPO Share Price of Vincent Medical Holdings Limited (Stock code: 01612)

(Hong Kong – 12 Jul 2016) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Vincent Medical Holdings Limited ("Vincent Medical"; stock code: 01612) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Vincent Medical on PhillipMart were HK\$1.05 and HK\$0.95. The price closed at HK\$0.96 per share, 4% lower than its offer price of HK\$1. The price opened at HK\$1.05, with the most actively traded price of HK\$0.97 per share, and a turnover of 406,000 shares. The total trading volume reached 1,308,000 shares with **total turnover of HK\$1,282,420.00**. The final price of Vincent Medical, to debut trading tomorrow has been fixed at HK\$1 per share.
