

## PhillipMart Announces Pre-IPO Share Price of Hailan Holdings Limited (Stock code: 02278)

(Hong Kong – 14 Jul 2016) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Hailan Holdings Limited ("Hailan Hldgs"; stock code: 02278) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Hailan Hldgs on PhillipMart were HK\$4.73 and HK\$4.1. The price closed at HK\$4.65 per share, 17.42% higher than its offer price of HK\$3.96. The price opened at HK\$4.1, with the most actively traded price of HK\$4.5 per share, and a turnover of 40,000 shares. The total trading volume reached 124,000shares with **total turnover of HK\$564,050**. The final price of Hailan Hldgs, to debut trading tomorrow has been fixed at HK\$3.96 per share.
