## PhillipMart Announces Pre-IPO Share Price of Singasia Holdings Limited (Stock code: 08293)

(Hong Kong – 14 Jul 2016) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Singasia Holdings Limited ("Singasia Hldg"; stock code: 08293) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Singasia Hldg on PhillipMart were HK\$1.5 and HK\$1.2. The price closed at HK\$1.49 per share, 49% higher than its offer price of HK\$1. The price opened at HK\$1.2, with the most actively traded price of HK\$1.35 per share, and a turnover of 200,000 shares. The total trading volume reached 350,000shares with **total turnover of HK\$466,750**. The final price of Singasia Hldg, to debut trading tomorrow has been fixed at HK\$1 per share.
