

**PhillipMart Announces Pre-IPO Share Price of  
 Quanzhou Huixin Micro-credit Co., Ltd (Stock code: 1577)**

(Hong Kong – 29 Sept 2016 ) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Quanzhou Huixin Micro-credit Co., Ltd (“Quanzhou Huixin”; stock code: 1577) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Quanzhou Huixin on PhillipMart were HK\$2 and HK\$1.8. The price closed at HK\$1.97 per share, 17.26% higher than its offer price of HK\$1.68. The price opened at HK\$1.8, with the most actively traded price of HK\$1.91 per share, and a turnover of 248,000 shares. The total trading volume reached 750,000 shares with **total turnover of 1,427,280.00**. The final price of Quanzhou Huixin, to debut trading tomorrow has been fixed at HK\$1.68 per share.
