## **PhillipMart Announces Pre-IPO Share Price of Rici Healthcare Holdings Limited (Stock code: 1526)**

(Hong Kong – 05 Oct 2016) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Rici Healthcare Holdings Limited ("Rici Healthcare"; stock code: 1526) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Rici Healthcare on PhillipMart were HK\$2.64 and HK\$2.45. The price closed at HK\$2.47 per share, 3.52% lower than its offer price of HK\$2.56. The price opened at HK\$2.64, with the most actively traded price of HK\$2.47 per share, and a turnover of 150,000 shares. The total trading volume reached 245,000 shares with total turnover of 612,370.00. The final price of Rici Healthcare, to debut trading tomorrow has been fixed at HK\$2.56 per share.
