PhillipMart Announces Pre-IPO Share Price of SMART-CORE HOLDINGS Limited (Stock code: 2166)

(Hong Kong – 06 Oct 2016) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of SMART-CORE HOLDINGS Limited ("SMART-CORE"; stock code: 2166) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for SMART-CORE on PhillipMart were HK\$1.89 and HK\$1.84. The price closed at HK\$1.89 per share, the same than its offer price of HK\$1.83. The price opened at HK\$1.87, with the most actively traded price of HK\$1.89 per share, and a turnover of 346,000 股 shares.
