

PhillipMart Announces Pre-IPO Share Price of Kwong Man Kee Group Limited (Stock code: 8023)

(Hong Kong – 12 Oct 2016) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Kwong Man Kee Group Limited ("Kwong Man Kee"; stock code: 8023) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Kwong Man Kee on PhillipMart were HK\$0.54 and HK\$0.485. The price closed at HK\$0.56 per share, the same than its offer price of HK\$0.43. The price opened at HK\$0.5, with the most actively traded price of HK\$0.53 per share, and a turnover of 1,116,000 shares. The total trading volume reached 6,210,000 shares with **total turnover of 3,257,790.00**. The final price of Kwong Man Kee, to debut trading tomorrow has been fixed at HK\$0.43 per share.
