PhillipMart Announces Pre-IPO Share Price of IBI Group Holdings Limited (Stock code: 1547)

(Hong Kong – 13 Oct 2016) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of IBI Group Holdings Limited ("IBI"; stock code: 1547) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for IBI on PhillipMart were HK\$0.6 and HK\$0.51. The price closed at HK\$0.55 per share, the same than its offer price of HK\$0.45. The price opened at HK\$0.6, with the most actively traded price of HK\$0.56 per share, and a turnover of 4,472,000 shares. The total trading volume reached 17,200,000 shares with total turnover of 18,806,400.00. The final price of IBI, to debut trading tomorrow has been fixed at HK\$0.45 per share.
