

## PhillipMart Announces Pre-IPO Share Price of Chong Kin Group Holdings Limited (Stock code: 1609)

(Hong Kong – 17 Oct 2016) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Chong Kin Group Holdings Limited ("Chong Kin"; stock code: 1609) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Chong Kin on PhillipMart were HK\$0.7 and HK\$0.63. The price closed at HK\$0.65 per share, the same than its offer price of HK\$0.7. The price opened at HK\$0.7, with the most actively traded price of HK\$0.65 per share, and a turnover of 2,210,000 shares. The total trading volume reached 8,940,000 shares with **total turnover of 6,039,900.00**. The final price of Chong Kin, to debut trading tomorrow has been fixed at HK\$0.7 per share.
