

**PhillipMart Announces Pre-IPO Share Price of
 China Industrial Securities Int'l Financial Group Limited (Stock code: 8407)**

(Hong Kong – 13 Oct 2016) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of China Industrial Securities Int'l Financial Group Limited (“China Industrial Securities”; stock code: 8407) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for China Industrial Securities on PhillipMart were HK\$1.36 and HK\$1.33. The price closed at HK\$1.35 per share, the same than its offer price of HK\$1.33. The price opened at HK\$1.33, with the most actively traded price of HK\$1.35 per share, and a turnover of 720,000 shares.
