## PhillipMart Announces Pre-IPO Share Price of China Resources Pharmaceutical Group Limited (Stock code: 3320)

(Hong Kong – 27 Oct 2016) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of China Resources Pharmaceutical Group Limited ("China Resources Pharmaceutical"; stock code: 3320) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for China Resources Pharmaceutical on PhillipMart were HK\$9 and HK\$8.5. The price closed at HK\$8.89 per share, the same than its offer price of HK\$9.1. The price opened at HK\$8.5, with the most actively traded price of HK\$8.8 per share, and a turnover of 378,000 shares. The total trading volume reached 1,208,000 shares with **total turnover of 10,574,375.00**. The final price of China Resources Pharmaceutical, to debut trading tomorrow has been fixed at HK\$9.1 per share.
