PhillipMart Announces Pre-IPO Share Price of COFCO Meat Holdings Limited (Stock code: 01610)

(Hong Kong – 31 Oct 2016) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of COFCO Meat Holdings Limited ("COFCO Meat"; stock code: 01610) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for COFCO Meat on PhillipMart were HK\$1.98 and HK\$1.92. The price closed at HK\$1.98 per share, 1% lower than its offer price of HK\$2. The price opened at HK\$1.98, with the most actively traded price of HK\$1.92 per share, and a turnover of 590,000 shares. The total trading volume reached 870,000 shares with **total turnover of \$1,678,160.00**. The final price of COFCO Meat, to debut trading tomorrow has been fixed at HK\$2 per share.
