

## PhillipMart Announces Pre-IPO Share Price of China Art Financial Holdings Limited (Stock code: 01572)

(Hong Kong – 8 Nov 2016) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of China Art Financial Holdings Limited ("China Art Financial"; stock code: 01572) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for China Art Financial on PhillipMart were HK\$0.76 and HK\$0.75. The price closed at HK\$0.76 per share, 1.33% higher than its offer price of HK\$0.75. The price opened at HK\$0.75, and also the most actively traded price of HK\$0.75 per share, and a turnover of 100,000 shares. The total trading volume reached 632,0000shares with **total turnover of \$475,000.00**. The final price of China Art Financial, to debut trading tomorrow has been fixed at HK\$0.75 per share.
