

**PhillipMart Announces Pre-IPO Share Price of
 Clifford Modern Living Holdings Limited (Stock code: 03686)**

(Hong Kong – 8 Nov 2016) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Clifford Modern Living Holdings Limited (“Clifford Modern Living”; stock code: 03686) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Clifford Modern Living on PhillipMart were HK\$0.5 and HK\$0.445. The price closed at HK\$0.5 per share, 8.7% higher than its offer price of HK\$0.46. The price opened at HK\$0.465, with the most actively traded price of HK\$0.485 per share, and a turnover of 7,510,000shares. The total trading volume reached 25,670,000shares with **total turnover of \$12,467,700.00**. The final price of Clifford Modern Living, to debut trading tomorrow has been fixed at HK\$0.46 per share.
