

**PhillipMart Announces Pre-IPO Share Price of  
 Zhou Hei Ya International Holdings Company Limited (Stock code: 01458)**

(Hong Kong – 10Nov2016 ) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Zhou Hei Ya International Holdings Company Limited (“Zhou Hei Ya”; stock code: 1458) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Zhou Hei Ya on PhillipMart were HK\$5.8 and HK\$5.8. The price closed at HK\$5.8 per share, 1.36% lower than its offer price of HK\$5.88. The price opened at HK\$5.8, with the most actively traded price of HK\$5.8 per share, and a turnover of 120,000 shares. The total trading volume reached 190,000 shares with **total turnover of 1,104,200**. The final price of Zhou Hei Ya, to debut trading tomorrow has been fixed at HK\$5.88 per share.
