## PhillipMart Announces Pre-IPO Share Price of Gemilang International Limited (Stock code: 06163)

(Hong Kong – 10Nov2016) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Gemilang International Limited ("Gemilang International Limited"; stock code: 06163) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Gemilang International Limited on PhillipMart were HK\$1.53 and HK\$1.36. The price closed at HK\$1.52 per share, 18.75% higher than its offer price of HK\$1.28. The price opened at HK\$1.38, with the most actively traded price of HK\$1.48 per share, and a turnover of 206,000 shares. The total trading volume reached 676,000 shares with **total turnover of \$1,003,900.00**. The final price of Gemilang International Limited, to debut trading tomorrow has been fixed at HK\$1.28 per share.
