## PhilipMart Announces Pre-IPO Share Price of PANTRONICS HOLDINGS LIMITED (Stock code: 01611)

(Hong Kong – 18 Nov C11.672016) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of PANTRONICS HOLDINGS LIMITED ("PANTRONICS HLDG"; stock code: 01611) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for PANTRONICS HLDG on PhillipMart were HK\$1.69 and HK\$1.58. The price closed at HK\$1.65 per share, 10% higher than its offer price of HK\$1.5. The price opened at HK\$1.67, with the most actively traded price of HK\$1.6 per share, and a turnover of 592,000 shares. The total trading volume reached 3,730,000 shares with **total turnover of \$6,062,060.00**. The final price of PANTRONICS HLDG, to debut trading on 21 Nov 2016. It has been fixed at HK\$1.5 per share.
