## PhillipMart Announces Pre-IPO Share Price of VPower Group International Holdings Limited (Stock code: 01608)

(Hong Kong – 23 Nov 2016) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of VPower Group International Holdings Limited ("VPower Group"; stock code: 01608) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for VPower Group on PhillipMart were HK\$2.98 and HK\$2.78. The price closed at HK\$2.91 per share, 1.04% higher than its offer price of HK\$\$2.88. The price opened at HK\$2.98, with the most actively traded price of HK\$2.92 per share, and a turnover of 291,000shares. The total trading volume reached 876,000shares with **total turnover of HK\$2,553,100.00**. The final price of VPower Group, to debut trading tomorrow has been fixed at HK\$2.88per share.
