

PhillipMart Announces Pre-IPO Share Price of Mengke Holdings Limited (Stock code: 01629)

(Hong Kong – 24 Nov 2016) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Mengke Holdings Limited ("Mengke Holdings"; stock code: 01629) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Mengke Holdings on PhillipMart were HK\$0.79 and HK\$0.7. The price closed at HK\$0.79 per share, 12.86% higher than its offer price of HK\$0.7. The price opened at HK\$0.77, with the most actively traded price of HK\$0.75 per share, and a turnover of 1,540,000 shares. The total trading volume reached 7,228,000shares with **total turnover of \$5,466,000.00**. The final price of Mengke Holdings, to debut trading tomorrow has been fixed at HK\$0.7 per share.
