

PhillipMart Announces Pre-IPO Share Price of FOOD WISE HOLDINGS LIMITED (Stock code: 01632)

(Hong Kong – 28 Nov 2016) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of FOOD WISE HOLDINGS LIMITED ("FOOD WISE HLDG"; stock code: 01632) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for FOOD WISE HLDG on PhillipMart were HK\$2.9 and HK\$2.06. The price closed at HK\$2.9 per share, 45% higher than its offer price of HK\$2. The price opened at HK\$2.1, with the most actively traded price of HK\$2.34 per share, and a turnover of 1,152,000 shares. The total trading volume reached 8,230,000 shares with **total turnover of \$19,459,220.00**. The final price of FOOD WISE HLDG, to debut trading tomorrow has been fixed at HK\$2 per share.
