

**PhillipMart Announces Pre-IPO Share Price of  
 Progressive Path Group Holdings Limited (Stock code: 01581)**

(Hong Kong – 7 Dec 2016) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Progressive Path Group Holdings Limited (“Progressive Path”; stock code: 01581) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Progressive Path on PhillipMart were HK\$0.78 and HK\$0.67. The price closed at HK\$0.7 per share, 16.67% higher than its offer price of HK\$0.6. The price opened at HK\$0.72, with the most actively traded price of HK\$0.7 per share, and a turnover of 5,605,000 shares. The total trading volume reached 21,190,000 shares with **total turnover of HK\$15,091,400.00**. The final price of Progressive Path, to debut trading tomorrow has been fixed at HK\$0.6 per share.
