

**PhillipMart Announces Pre-IPO Share Price of  
 CSC Financial Co., Ltd. (Stock code: 06066)**

(Hong Kong – 8 Dec 2016) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of CSC Financial Co., Ltd. (“CSC”; stock code: 06066) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for CSC on PhillipMart were HK\$6.9 and HK\$6.82. The price closed at HK\$6.83 per share, 0.29% higher than its offer price of HK\$6.81. The price opened at HK\$6.82, with the most actively traded price of HK\$6.86 per share, and a turnover of 516,500 shares. The total trading volume reached 340,000 shares with **total turnover of HK\$11,747,025.00**. The final price of CSC, to debut trading tomorrow has been fixed at HK\$6.81 per share.
