

**PhillipMart Announces Pre-IPO Share Price of
 Nanfang Communication Holdings Limited (Stock code: 01617)**

(Hong Kong – 9 Dec 2016) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Nanfang Communication Holdings Limited (“Nanfang Communication”; stock code: 01617) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Nanfang Communication on PhillipMart were HK\$1.26 and HK\$1.08. The price closed at HK\$1.23 per share, 20.59% higher than its offer price of HK\$1.02. The price opened at HK\$1.08, with the most actively traded price of HK\$1.17 per share, and a turnover of 560,000 shares. The total trading volume reached 3,172,000shares with **total turnover of \$3,798,280**. The final price of Nanfang Communication, to debut trading tomorrow has been fixed at HK\$1.02 per share.
