

PhillipMart Announces Pre-IPO Share Price of Meitu, Inc. (Stock code: 01357)

(Hong Kong – 14 Dec 2016) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Meitu, Inc. (stock code: 01357) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Meitu, Inc. on PhillipMart were HK\$8.99and HK\$8.40. The price closed at HK\$8.69 per share,2.24% higher than its offer price of HK\$\$8.50 The price opened at HK\$8.50, with the most actively traded price of HK\$8.62 per share, and a turnover of 1,267,500shares. The total trading volume reached 6,189,000shares with **total turnover of HK\$53,360,670.00**. The final price of Meitu, Inc, to debut trading tomorrow has been fixed at HK\$8.50per share.
