

**PhillipMart Announces Pre-IPO Share Price of  
 EFT Solutions Holdings Limited (Stock code: 08062)**

(Hong Kong – 14 Dec 2016) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of EFT Solutions Holdings Limited (“EFT Solutions” stock code: 08062) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for EFT Solutions, on PhillipMart were HK\$0.56 and HK\$0.69. The price closed at HK\$0.77 per share, 37.5% higher than its offer price of HK\$0.56. The price opened at HK\$0.69, with the most actively traded price of HK\$0.76 per share, and a turnover of 11,040,000 shares. The total trading volume reached 27,005,000 shares with **total turnover of HK\$20,657,400.00**. The final price of EFT Solutions, to debut trading tomorrow has been fixed at HK\$0.56 per share.
