

## PhillipMart Announces Pre-IPO Share Price of Hebei Yichen Industrial Group Corporation Limited (Stock code: 1596)

(Hong Kong – 20 Dec 2016) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Hebei Yichen Industrial Group Corporation Limited ("Hebei Yichen"; stock code: 1596) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Hebei Yichen on PhillipMart were HK\$3.12 and HK\$3.04. The price closed at HK\$3.1 per share, 3.33% higher than its offer price of HK\$3. The price opened at HK\$3.05, with the most actively traded price of HK\$3.1 per share, and a turnover of 1,144,000 shares. The total trading volume reached 3,934,000 shares with **total turnover of \$12,147,080.00**. The final price of Hebei Yichen, to debut trading tomorrow has been fixed at HK\$3 per share.
