

**PhillipMart Announces Pre-IPO Share Price of
 SH Group (Holdings) Limited (Stock code: 1637)**

(Hong Kong – 30 Dec 2016) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of SH Group (Holdings) Limited (“SH Group”; stock code: 1637) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for SH Group on PhillipMart were HK\$1.7 and HK\$1.35. The price closed at HK\$1.67 per share, 39.17% higher than its offer price of HK\$1.2. The price opened at HK\$1.35, with the most actively traded price of HK\$1.66 per share, and a turnover of 1,212,000 shares. The total trading volume reached 14,144,000 shares with **total turnover of 21,457,200.00**. The final price of SH Group, to debut trading tomorrow has been fixed at HK\$1.2 per share.
