

**PhillipMart Announces Pre-IPO Share Price of  
 Yuk Wing Group Holdings Limited (Stock code: 01536)**

(Hong Kong – 10 Jan 2017 ) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Yuk Wing Group Holdings Limited (“Yuk Wing Group”; stock code: 01536) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Yuk Wing Group on PhillipMart were HK\$1.25 and HK\$1.13. The price closed at HK\$1.13 per share, 1.74% lower than its offer price of HK\$1.15. The price opened at HK\$1.15, with the most actively traded price of HK\$1.19 per share, and a turnover of 3,084,000 shares. The total trading volume reached 11,940,000shares with **total turnover of HK\$14,097,300.00**. The final price of Yuk Wing Group, to debut trading tomorrow has been fixed at HK\$1.15 per share.
