

PhillipMart Announces Pre-IPO Share Price of Morris Holdings Limited (Stock code: 01575)

(Hong Kong – 11 Jan 2017) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Morris Holdings Limited ("Morris Holdings"; stock code: 01575) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Morris Holdings on PhillipMart were HK\$1.25 and HK\$1.11. The price closed at HK\$1.25 per share, 19.05% higher than its offer price of HK\$1.05. The price opened at HK\$1.15, with the most actively traded price of HK\$1.25 per share, and a turnover of 1,008,000 shares. The total trading volume reached 3,650,000shares with **total turnover of HK\$4,385,520.00**. The final price of Morris Holdings, to debut trading tomorrow has been fixed at HK\$1.05 per share.
