## PhillipMart Announces Pre-IPO Share Price of ISDN Holdings Limited (Stock code: 01656)

(Hong Kong – 11 Jan 2017) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of ISDN Holdings Limited ("ISDN Holdings"; stock code: 01656) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for ISDN Holdings on PhillipMart were HK\$1.7 and HK\$1.5. The price closed at HK\$1.66 per share, 32.8% higher than its offer price of HK\$1.25. The price opened at HK\$1.5, with the most actively traded price of HK\$1.65 per share, and a turnover of 832,000 shares. The total trading volume reached 5,136,000 shares with total turnover of HK\$8,437,920.00. The final price of ISDN Holdings, to debut trading tomorrow has been fixed at HK\$1.25 per share.
