## **PhillipMart Announces Pre-IPO Share Price of** JIUTAI Rural Commerical Bank (Stock code: 06122)

(Hong Kong – 11 Jan 2017) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of JIUTAI Rural Commerical Bank ("JIUTAI RCB"; stock code: 06122) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for JIUTAI RCB on PhillipMart were HK\$4.57 and HK\$4.57. The price closed at HK\$4.57 per share, 0.22% higher than its offer price of HK\$4.56. The price opened at HK\$4.57, with the most actively traded price of HK\$4.57 per share, and a turnover of 9,000 shares. The total trading volume reached 9,000 shares with total turnover of HK\$41,130.00. The final price of JIUTAI RCB, to debut trading tomorrow has been fixed at HK\$4.56 per share.
