

PhillipMart Announces Pre-IPO Share Price of WWPKG Holdings Company Limited (Stock code: 08069)

(Hong Kong – 11 Jan 2017) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of WWPKG Holdings Company Limited ("WWPKG Holdings"; stock code: 08069) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for WWPKG Holdings on PhillipMart were HK\$1.08 and HK\$0.91. The price closed at HK\$0.94 per share, 17.5% higher than its offer price of HK\$0.8. The price opened at HK\$1.08, with the most actively traded price of HK\$0.94 per share, and a turnover of 4,080,000 shares. The total trading volume reached 14,055,000 shares with **total turnover of HK\$13,227,400.00**. The final price of WWPKG Holdings, to debut trading tomorrow has been fixed at HK\$0.8 per share.
