

**PhillipMart Announces Pre-IPO Share Price of  
 New Century Healthcare Holding Co. Limited (Stock code: 01518)**

(Hong Kong – 17 Jan 2017 ) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of New Century Healthcare Holding Co. Limited (“NC Healthcare”; stock code: 01518) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for NC Healthcare on PhillipMart were HK\$7.7 and HK\$7.36. The price closed at HK\$7.7 per share, 4.62% higher than its offer price of HK\$7.36. The price opened at HK\$7.36, with the most actively traded price of HK\$7.6 per share, and a turnover of 4000 shares. The total trading volume reached 9,000shares with **total turnover of \$68,220.00**. The final price of NC Healthcare, to debut trading tomorrow has been fixed at HK\$7.36 per share.
