

## PhillipMart Announces Pre-IPO Share Price of Wisdom Education International Holdings Company Limited (Stock code: 06068)

(Hong Kong – 25 Jan 2017) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Wisdom Education International Holdings Company Limited ("Wisdom Edu Intl"; stock code: 06068) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Wisdom Edu Intl on PhillipMart were HK\$1.76 and HK\$1.68. The price closed at HK\$1.68 per share, 1.18% lower than its offer price of HK\$1.7. The price opened at HK\$1.75, with the most actively traded price of HK\$1.7 per share, and a turnover of 1,990,000 shares. The total trading volume reached 2,552,000 shares with **total turnover of \$4,360,000.00**. The final price of Wisdom Edu Intl, to debut trading tomorrow has been fixed at HK\$1.7 per share.
