## **PhillipMart Announces Pre-IPO Share Price of ROYAL DELUXE HOLDINGS LIMITED (Stock code: 03789)**

(Hong Kong – 17 Feb 2017) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Meitu, Inc. (stock code: 03789) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for ROYAL DELUXE, Inc. on PhillipMart were HK\$0.64 and HK\$0.5. The price closed at HK\$0.51 per share 8.93% lower than its offer price of HK\$\$0.56. The price opened at HK\$0.64, with the most actively traded price of HK\$0.56 per share, and a turnover of 4,660,000 shares. The total trading volume reached 20,380,000shares with total turnover of HK\$11,174,000.00. The final price of ROYAL DELUXE, to debut trading tomorrow has been fixed at HK\$0.56 per share.
