

**PhillipMart Announces Pre-IPO Share Price of
 Sanroc International Holdings Limited (Stock code: 01660)**

(Hong Kong – 9 Feb 2017) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Sanroc International Holdings Limited** (stock code: 01660) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Sanroc Int’I on PhillipMart were HK\$0.42 and HK\$0.36. The price closed at HK\$0.39 per share, 2.5% lower than its offer price of HK\$0.4. The price opened at HK\$0.4, with the most actively traded price of HK\$0.39 per share, and a turnover of 4,048,000 shares. The total trading volume reached 15,552,000 shares with **total turnover of HK\$6,032,680.00**. The final price of Sanroc Int’I, to debut trading tomorrow has been fixed at HK\$0.4 per share.
