

**PhillipMart Announces Pre-IPO Share Price of
 Lai Si Enterprise Holding Limited (Stock code: 02266)**

(Hong Kong – 9 Feb 2017) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Lai Si Enterprise Holding Limited** (stock code: 02266) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Lai Si Enterprise** on PhillipMart were HK\$1.31 and HK\$1.15. The price closed at HK\$1.3 per share, 13.04% higher than its offer price of HK\$1.15. The price opened at HK\$1.24, with the most actively traded price of HK\$1.27 per share, and a turnover of 1,176,000 shares. The total trading volume reached 8,046,000 shares with **total turnover of HK\$10,155,420.00**. The final price of **Lai Si Enterprise**, to debut trading tomorrow has been fixed at HK\$1.15 per share.
