

PhillipMart Announces Pre-IPO Share Price of Dadi Education Holdings Limited (Stock code: 08417)

(Hong Kong – 15 Feb 2017) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Dadi Education Holdings Limited (stock code: 08417) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Dadi Education on PhillipMart were HK\$0.375and HK\$0.355. The price closed at HK\$0.36 per share,5.88% higher than its offer price of HK\$\$0.34. The price opened at HK\$0.36, with the most actively traded price of HK\$0.36 per share, and a turnover of 31,650,000shares. The total trading volume reached 56,750,000shares with **total turnover of HK\$20,559,000**. The final price of Dadi Education, to debut trading tomorrow has been fixed at HK\$0.34per share.
