

PhillipMart Announces Pre-IPO Share Price of Able Engineering Holdings Limited (Stock code: 01627)

(Hong Kong – 17 Feb 2017) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Able Engineering (stock code: 01627) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Able Engineering** on PhillipMart were HK\$1.03 and HK\$0.89. The price closed at HK\$0.89 per share,19.09% lower than its offer price of HK\$1.10 The price opened at HK\$1.03, the most actively traded price of HK\$0.9, and a turnover of 2,056,000 shares. The total trading volume reached 5,808,000 shares with **total turnover of HK\$5,349,200.00.** The final price of **Able Engineering**, to debut trading tomorrow has been fixed at HK\$1.10 per share.
