

## PhillipMart Announces Pre-IPO Share Price of Microware Group Limited (Stock code: 01985)

(Hong Kong – 7 March 2017) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Microware Group Limited (stock code: 01985) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Microware Group Limited on PhillipMart were HK\$3.97and HK\$1.7. The price closed at HK\$3.89 per share,166.44% higher than its offer price of HK\$\$1.46. The price opened at HK\$1.7, with the most actively traded price of HK\$3.61 per share, and a turnover of 848,000shares. The total trading volume reached 12,202,000shares with **total turnover of HK\$40,349,300.00**. The final price of Microware, to debut trading tomorrow has been fixed at HK\$1.46 per share.
