

**PhillipMart Announces Pre-IPO Share Price of  
 Presta Resources Inc. (Stock code: 03395)**

(Hong Kong – 9 March 2017) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Presta Resources Inc.** (stock code: 03395) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Presta** on PhillipMart were HK\$5.00 and HK\$3.24. The price closed at HK\$4.60 per share, 45.57% higher than its offer price of HK\$3.16. The price opened at HK\$3.24, with the most actively traded price of HK\$3.24 per share, and a turnover of 33,000 shares. The total trading volume reached 82,000 shares with **total turnover of HK\$304,100.00**. The final price of **Presta**, to debut trading tomorrow has been fixed at HK\$3.16 per share.
