## PhillipMart Announces Pre-IPO Share Price of Chi Ho Development Holdings Limited (Stock code: 08423)

(Hong Kong – 10 March 2017) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Chi Ho Development Holdings Limited (Chi Ho Dev, stock code:** 08423) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Chi Ho Dev** on PhillipMart were HK\$0.34 and HK\$0.305. The price closed at HK\$0.31 per share, 3.33% higher than its offer price of HK\$\$0.3. The price opened at HK\$0.34, with the most actively traded price of HK\$0.31 per share, and a turnover of 660,000shares.
