

**PhillipMart Announces Pre-IPO Share Price of  
 Hing Ming Holdings Limited (Stock code: 08425)**

(Hong Kong – 14 March 2017) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Hing Ming Holdings Limited** (stock code: 08425) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Hing Ming** on PhillipMart were HK\$0.78 and HK\$0.76. The price closed at HK\$0.77 per share, 2.67% higher than its offer price of HK\$0.75. The price opened at HK\$0.78, with the most actively traded price of HK\$0.77 per share, and a turnover of 768,000 shares. The total trading volume reached 1,328,000 shares with **total turnover of HK\$1,026,960.00**. The final price of **Hing Ming**, to debut trading tomorrow has been fixed at HK\$0.75 per share.
