

**PhillipMart Announces Pre-IPO Share Price of
 Hospital Corporation of China Limited (Stock code: 03869)**

(Hong Kong – 15 March 2017) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Hospital Corporation of China Limited (Hospital Corp)** stock code: 03869) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Hospital Corp** on PhillipMart were HK\$13.00 and HK\$12.70. The price closed at HK\$12.94 per share, 1.09% higher than its offer price of HK\$12.80. The price opened at HK\$12.90, with the most actively traded price of HK\$12.94 per share, and a turnover of 39,800 shares. The total trading volume reached 124,800 shares with **total turnover of HK\$1,611,948.00**. The final price of **Hospital Corporation**, to debut trading tomorrow has been fixed at HK\$12.8per share.
