

PhillipMart Announces Pre-IPO Share Price of WINSON Holdings Hong Kong Limited (Stock code: 08421)

(Hong Kong – 15 March 2017) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of WINSON Holdings Hong Kong Limited ("WINSON Hldgs HK"; stock code: 08421) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for WINSON Hldgs HK on PhillipMart were HK\$0.51 and HK\$0.45. The price closed at HK\$0.455 per share, 8.332% higher than its offer price of HK\$0.42. The price opened at HK\$0.465, with the most actively traded price of HK\$0.455 per share, and a turnover of 1,635,000shares. The total trading volume reached 4,090,000shares with **total turnover of HK\$1,881,950.00**. The final price of **WINSON Hldgs HK**, to debut trading tomorrow has been fixed at HK\$0.42 per share.
